

## **Licence agreement for use of articles funded by NIH and published in the British Journal of Psychiatry Open (BJPsych Open)**

### **Background**

The Royal College of Psychiatrists ("College"), which publishes the British Journal of Psychiatry Open ("Journal"), offers authors of research articles wholly or partly funded by NIH and accepted for publication in the Journal the option to have their articles made freely available electronically from the PubMed Central (PMC) and UK PubMed Central (UKPMC) repositories from 12 months after the time of publication, or from the time of publication upon payment of a fee.

The copyright in all such articles accepted for publication in the Journal belongs to the College. The College will deposit the final peer-reviewed article, as published, in PMC/UKPMC. Subsequent use of the article is governed by the terms of the following Licence.

### **Licence**

1. Copyright in the article, unless otherwise noted, belongs to the Royal College of Psychiatrists.
2. Users are permitted to reproduce or disseminate articles within the parameters of applicable copyright law.
3. Downloading, printing, or saving of articles for the purposes of research, teaching, and/or private study by is permissible.
4. Redistribution of articles in electronic or digital form is prohibited without prior publisher approval.
5. Accessibility: users may transcribe any portion of articles into Braille script, enlarged type or other appropriate version in order to allow users with disabilities to access the articles.
6. Reprints: For permission to reprint or copy articles beyond that permitted by Section 107 or 108 of the U.S. Copyright Law, contact the publishers: [publications@rcpsych.ac.uk](mailto:publications@rcpsych.ac.uk).
7. Users must not remove, cover, overlay, obscure, block, or change any copyright notices, legends, or terms of use.
8. Modification: users shall not modify or create a derivative work from any article without the prior written permission of the publishers.
9. To the fullest extent permitted by law, the College excludes all representations, warranties or conditions of any kind concerning the article, whether express, implied, statutory or otherwise, including

without limitation warranties of title, merchantability, fitness for a particular purpose, non-infringement or accuracy.

10. To the fullest extent permitted by law, in no event will the College be liable to the User for any losses or damages of any kind, including without limitation any special, indirect or consequential losses or damages, howsoever arising out of this Licence and/or the use of the article.
11. Without prejudice to this Licence, the College reserves the right at any time to release the article under different terms of licence and/or to cease distribution of the article.
